Attention is drawn to the fact that the consolidated figures corresponding quarter ended June 30, 2023 as reported in these financial results have been approved by the Company's Board of Directors, but have not been subjected to review.


The impact of all the above is unascertainable. Our Conclusion is not modified in respect of these matters.
